## 2010 Assistance to Firefighters Grant Program

The Department of Homeland Security has announced the availability of funding for the 2010 Assistance to Firefighters Grant. The application period is now open and applications will be accepted until May 28.

**As in past years, local assistance staff at Region XII Council of Governments can assist departments in our region with writing and submitting grant applications. This service is provided at no charge to the departments.** Region XII has worked with many area departments in the past to prepare and submit quality applications of which several have received funding.

Fire departments, fire districts and non-affiliated EMS organizations are eligible to apply for the competitive program. Previous grant recipients are eligible to apply again in 2010. There are two categories of funding for this program. The funding categories are as follows:

**Operations and Safety:** Eligible activities include: training, equipment, personal protective equipment, wellness and fitness, and fire station modifications.

**Vehicle Acquisition:** Acquiring additional firefighting or EMS vehicles, including apparatus, or refurbishing apparatus currently owned.
