COG HOUSING DEVELOPMENT ASSISTANCE

Council of Governments Housing (COGH) is the local housing trust fund for Audubon, Carroll, Crawford, Greene, Guthrie and Sac Counties. COGH may award up to \$50,000 for projects that create new housing units in the counties of Audubon, Carroll, Crawford, Greene, Guthrie, and Sac in Iowa. A new unit may be one that is newly constructed or one that rehabilitates a vacant unit or converts previously non-housing space into a housing unit. The maximum amount of funds awarded will be \$25,000/unit, although applications asking for less will be scored more favorably. Assistance may come in the form of a forgivable loan (a loan that has no payments and a principal balance that will recede over time) or a zero-interest loan. (Repayable loans will score more highly).

COG Housing funding comes through the state housing trust fund, allocated each year by the Iowa legislature, and as such must be used to benefit low and moderate income persons. Note the following:

- 1. All awards made from this fund shall create housing units that benefit persons who are at or below 80% of median income for their respective county.
- 2. Funding may not be available until after June 1, 2021.
- 3. Equal opportunity housing standards shall apply.
- 4. All applicants are required to provide local cash match.
- 5. Applications will be evaluated on the amount of local match provided and type of match requested. All funds must run through the COGH accounting system (the State of Iowa only counts match that flows through the books of the COGH organization). All match funds will be remitted back to the awardee with the forgivable/loan award. For example, a project is awarded \$10,000 toward a \$50,000 project that will create two housing units. The awardee proposed \$10,000 in match and therefore will pay \$10,000 to COG Housing and receive \$20,000 as an award.
