WIAD hosted its third Employer-Educator Summit in September, an even that has grown to attract nearly 150 persons from K-12, colleges, corporations, and partner entities. "The Employer-Educator Summit represents one of WIAD's tangible products to grow our incumbent workforce," said Evan Blakely, CDC Executive Director and chair of WIAD. While the vision and impacts are long term, we are witnessing greater partnerships between industries and our educational institutions that are revealing for students and parents all of the rewarding career opportunities available in western Iowa."

The Summit continues to focus on preparing the region's workforce in a partnership between industries and the schools. Of particular interest is promoting, improving, and finding interested persons for the careers and career pathways available in west central Iowa.

"Rural areas across the country are struggling with workforce issues," commented Sarah Gomez, Executive Director of Midwest Partnership. "Our industries have benefitted from the time invested in the Summit, and we are seeing interest in internships, apprenticeships, and other forms of cooperation with our schools."

Aside from keynote speeches from IEDA and IWD, local businesses discussed their perspective of doing business in western Iowa and careers available here. Participants were broken into workgroups to discuss these major issues: how businesses may retain students wishing to create their own path, potential activities that may inspire future workers to move to or remain in the region, methods to connect business to students, and entrepreneurial resources available to students.

Feedback continues to be positive from participants, and small groups will continue the work of the summit, planned to be held again in 2016.

WIAD's Employer-Educator Summit is a winner!

The Employer-Educator Summit received a 2015 Innovation Award from the National Association of Development Organizations (NADO). Also recognized for this event was Iowa Workforce Development (IWD), WI-AD's strategic partner in the Summit. NADO is a Washington, DCbased association that promotes programs and policies that strengthen local governments, communities, and economies through regional cooperation, program delivery, and comprehensive strategies. The association's Innovation Awards program recognizes regional development organizations and partnering organizations for improving the economic and community competitiveness of our nation's regions and local communities.

Derelict Building Program Deadline Approaching

Established in 2011, The Iowa Department of Natural Resources Derelict Building Program offers Iowa communities of 5,000 or fewer residents' financial assistance to address neglected structures which been vacant for at least six months. The Program's main focus is landfill diversion through the recycling and reuse of building materials. Since inception, this program has assisted 56 communities, diverted over 35,000 tons of materials and saved over \$1 million in landfill disposal costs. Municipal Leadership Academy Training Opportunities



The Municipal Leadership Academy (MLA) is designed to help municipal officials effectively meet the requirements of their office. The program offers a comprehensive overview of Iowa municipal government and is presented by the Iowa League of Cities, the Institute of Public Affairs at the University of Iowa, and the Office of State and Local Government Programs at Iowa State University Extension and Outreach.

There are two upcoming trainings with the first training (part 2) being released the first week of January 2016. This training can be viewed online at your convenience. View it all at once or separately in order to fit within

a city's orientation program for new officials. Cost is \$60. This training will cover the city budget, basics of planning and zoning, and "you got elected, now what?". The second training (part 3) is designed for those looking for more in-depth information on the challenges facing cities. The training costs \$75 and includes the latest information and policy guidance on economic development, community betterment and stragetic planning and goal setting.

Funds Available for Surface Transportation Projects

Region XII COG is preparing the 2017-2020 Transportation Improvement Program (TIP). These funds are available to any city or county in Region XII (Audubon, Carroll, Crawford, Greene, Guthrie or Sac Counties).

Region XII has approximately \$4,000,000 in Surface Transportation Project (STP) monies available for projects. Projects that are eligible include roadway construction and reconstruction, operational improvements, safety programs, and traffic management and control. STP funds can also be used for transit projects and other ride-share projects. Roadways that are eligible for funding must be classified as a major collector of higher on the federal functional classification system. The STP Application and Federal Functional Classification Maps can be viewed at www.region12cog.org under the Downloads and Publications Section.

The sponsoring governmental agency must provide at least 20% of the total project cost in cash. Applications are due by 4:00 PM on January 8, 2016. For additional information contact Chris Whitaker at 712-792-9914 or cwhitaker@region12cog.org.
